Dear Craig:

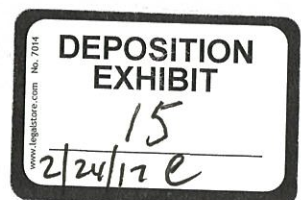
We have to put in operation the 1 MW plant, that we are ready to put in operation since when we delivered it, in August 2013. It has been delivered perfectly ready to go, as it has been turned off after the May test. It has not been possible to put it in operation for reasons independent from us: location where to put it in operation, authorizations etc. I inspected it few days ago, and we made some remarks: 1 E-Cat is disappeared, many valves had been wrongly manipulated etc. I sent a report. We are waiting to be ready to put it in operation. It is not possible to put some modules out, by contract. We had offered to make the test with the Hot Cat, and we had sent to you an amendment, already signed by me and by Tom Darden, but for reasons remained mysterious to me Ampenergo did not sign and the amendment has been cancelled.
